Non-resident: \$185. Any attorney admitted to any bar in the United States or the District of Columbia, whose principal practice is not in Hamilton County or in one of the contiguous counties of Dearborn, Butler, Warren, Clermont, Campbell, Kenton and Boone.

Law Faculty: \$185. Any attorney who is a full-time member of the faculty of any ABA-accredited law school.
